

FHTM REGIONAL BONUS ELIGIBILITY FORM



To qualify, a US or Canadian Representative must meet the following criteria:

- ⌘ Entered the business between *February 1, 2010 and March 31, 2010*
- ⌘ Achieved RSM status within 30 days of your entry date by gathering at least ten (10) personal customer points and twelve (12) managers within your first five (5) levels, at least three (3) of which are personally sponsored.
- ⌘ All ten (10) personal customer points must be active within sixty (60) days of your Representative enrollment date
- ⌘ If these qualifications are met, US and Canadian Representatives are eligible to receive \$500

Representatives who entered the business between **February 1, 2010 and February 28, 2010** and believe they qualify must fill out and fax in an eligibility form by **5:30 PM EST on Friday, April 9, 2010.**

Representatives who entered the business between **March 1, 2010 and March 31, 2010** and believe they qualify must fill out and fax in an eligibility form by **5:30 PM EST on Friday, May 7, 2010.**
